

Rules and Regulations

The normal hours of operation for the Blue Agave Pool Club are as follows:

Monday, Wednesday - Friday	11:00 am – 8:00 pm
Tuesday	Closed (Except for holidays)
Saturday & Sunday	10:00 pm – 7:00 pm

Hours may be changed at any time.

The pool will be closed every Tuesday, during unsafe weather conditions and any other time as deemed appropriate by the New Town® General Assembly. Anyone not following the rules may be asked to leave at Management's discretion. Rules are subject to change without notice.

NO LIFEGUARDS ARE PROVIDED. SWIM AT YOUR OWN RISK.

- POOL PASSES: Every person in the household must have a New Town resident or tenant identification card in order to enter the pool area. Guests are required to submit a guest pass. A pool pass must be shown upon entering NO EXCEPTIONS!
- GUEST PASSES: **Children 2 & under are free**. Residents may invite two (2) guests and they must have guest passes. Only a resident may purchase a guest pass & the resident MUST accompany their guest. All **guest passes may be purchased at the Shire Lane Pool during regular operating hours** (Shire Lane Pool is closed on Mondays). Guest Passes are \$5.00 each (non-refundable) ALL GUEST PASSES MUST be turned in to attendant. Guests may be limited at any time at Management's discretion. RESIDENTS MUST REMAIN WITH ALL GUESTS AT ALL TIMES.
- POOL ATTIRE:
 - a. Diapers Swim diapers will be required on persons that normally require diapers in the facility.
 - b. Non-swim diapers are prohibited.
 - c. Pool shoes are strongly recommended.
- YOUNG CHILDREN As required by the Aquatic & Recreational Facilities Code for St. Charles County, youths under the age of 18 must be accompanied at all times by a responsible adult age 18 or older. All parents or guardians must be within arm's reach of non-swimmers.
- ADULT SUPERVISION As required by the Aquatic & Recreational Facilities Code for St. Charles County, a ratio of 2 swimming adults to every 5 children must be met for all groups with children of ages 2 – 4. For groups with children ages 5 –12, the ratio must be one swimming adult for every 8 children.
- FITNESS: Persons with contagious diseases, infectious conditions, open sores or wounds MUST stay out of the pool area.
- ALCHOLIC BEVERAGES The possession or consumption of alcoholic beverages is not permitted inside the pool facility during normal operations.

- UNDER THE INFLUENCE Any person suspected of being under the influence of a controlled substance will not be allowed entry to the facility, or; if inside the facility, they will be asked to leave.
- NO HORSEPLAY: Horseplay, running, shoving, dunking, and throwing objects such as tennis balls or rocks is not permitted. Personal conduct must ensure the safety all individuals.
- NO PROFANITY: Profanity, improper behavior, and drugs are expressly prohibited!
- NO DIVING: No diving is allowed.
- NO GLASS: No glass containers are allowed in the facility. Food items are allowed only under the gazebo.
- NO SMOKING: Smoking is not permitted inside the Blue Agave Facility.
- TRASH: All waste, trash and garbage must be placed in provided waste cans.
- POOL TOYS: Pool toys and rafts are allowed, Residents and their guest are encouraged to remove them if the pool becomes too crowded.
- RADIOS: No boom boxes or radios are allowed. Please use personal music headsets if desired.
- LOSS OR THEFT: Management is not responsible for lost or stolen property. Articles left at the pool will NOT BE saved and will be disposed of.
- NO PETS: Pets are not allowed in the pool area.
- MAINTENANCE: The pool may be closed for maintenance purposes, health conditions, or any reason deemed sufficient by Management.
